In the Federal Register for August 28, the Federal Motor Carrier Safety Administration finally responded to NSTA's 2002 request for clarification on the need for school bus contractors to acquire operating authority. In the Final Rule on Enforcement of Operating Authority, FMCSA writes:

NSTA requested clarification concerning the exemption at 49 U.S.C. 13506(a)(1) for "a motor vehicle transporting only school children and teachers to or from school." NSTA noted that during the period from 1976 through 1984, the former Interstate Commerce Commission (ICC) issued "rulings that established an interpretation of the exemption to include interstate transportation of students in school buses on trips that are directly connected with school-related activities and are sponsored and supervised by school authorities." It requested FMCSA to support this interpretation and clarify that the exemption includes for-hire motor carriers transporting students to school-related activities across State lines.

FMCSA Response: In response to NSTA's request for clarification, FMCSA has not issued any interpretations contradicting those of the former ICC. FMCSA recodified the former ICC rule implementing the exemption for motor vehicles employed solely

This gives those of you who run into differing interpretations from FMCSA field agents or from your state authorities written evidence that you do not need to acquire operating authority for interstate activity trips. It does not change the requirement that school bus

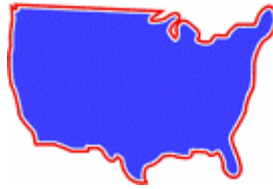
Congressional Schedule



Members of the House and Senate returned to Washington this week following the month-long August recess. The House is expected to adjourn at the end of the September and the Senate in early October. They will both stay in adjournment until after the November 7th elections. A "lame-duck" session of Congress is expected to convene mid-November.

While Congress has not cleared any of the 13 appropriations bills it must address each year, it is possible that the Homeland Security bill will be dispensed with prior to adjournment at the end of this month. It is widely expected that Congress will have to pass a Continuing Resolution to continue funding of government programs at Fiscal Year 2006 levels as there will be many unresolved bills by the end of this fiscal year (September 30, 2006). It is also expected that the Continuing Resolution will be effective until Congress's return mid-November.

The November elections could have a significant impact on where things go when Congress returns for the lame-duck session. If either the House or Senate were to change to a Democratic majority, it is possible that yet another Continuing Resolution will be considered, continuing current funding levels until early spring when the 110th Congress is sworn in, as was done in 2002. If both the House and Senate stay Republican, it is likely that Members will be in through late December trying to resolve their outstanding spending bills.



Outside the Beltway

Rhode Island: The Portsmouth, RI, school committee has asked the state Department of Education to waive their transportation requirements so they can reduce the school budget by \$1.1 million.

That's how much the town cut from the budget at a recent town meeting. Transportation is not the only requirement the district is asking to cut, but it is the largest one.

According to the superintendent, if the state allows the district to eliminate all school busing except for special needs students, they will come close to solving their budget problem. She conceded, though, that the state Department of Education has never granted waivers, and that they could not waive contractual obligations in any case.

Ohio: The Finneytown school district instituted a No Talking policy on school buses this year.

In a notice to parents, the administration said that the policy is necessary to ensure the safety of students by keeping the noise level low, and to help eliminate other disruptive behavior such as getting out of seats, teasing, and physical contact.

Students are allowed to talk in quiet voices in the school parking lots, and are directed to talk to the bus driver if there is a problem or in response to the driver's questions.



Mary Peters Nominated as New Secretary of Transportation

President Bush announced this week that he has chosen Mary Peters, the former Federal Highway Administrator, to succeed Norman Mineta as the new Secretary of Transportation. Peters was Administrator from 2001 to 2005. Prior to serving as Administrator, Peters spent 16 years with the Arizona Department of Transportation. Since serving as Administrator, Peters has been the national director for transportation policy and consulting with the Phoenix, Arizona office of the architectural, engineering and consulting firm of HDR, Inc.

The President called Peters "the right person for the job" and said, "Mary has a reputation for character and common sense. She's an innovative thinker. She knows how to set priorities and to solve problems."

Peters has been an advocate of user fees, or tolls, to finance new infrastructure. In a recent interview, she said, "you just can't depend on the Federal government to bring the money in that was around when the interstate system was first built."

The nomination will now be sent to the Senate Commerce, Science and Transportation Committee for consideration. Hearings on the nomination have yet to be scheduled.

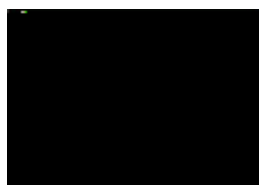




Volunteer Your Time to Help Rebuild Homes in New Orleans
